## H. OTHER ACTION ITEMS / PUBLIC HEARING

#### 1. Parks

a. City Park

A message board has been placed in the park. The flower beds have been cleaned and are looking good.

1) Music in the Park

Nothing at this time.

2) Movie in the Park

A movie was shown on October 24<sup>th</sup>at the YMCA. For the next year the Commission would like to coordinate with the YMCA to be the backup in case of bad weather.

3) Christmas in the Park

Parade begins at 10 a.m. on December 5<sup>th</sup> and the activities in the park begin about that time as well.

b. Splash Park

Heartland does have some ideas to enhance the splash park. Chairman Branam will get back in touch with them to hear the ideas. The possible water park was discussed.

c. Gardenview Park

Swing seats have been replaced.

d. Sports Complex

The complex is closed for maintenance. The fields have been aerated, over seeded with rye grass; Lyme has been put down and the fields fertilized. A pre-emergent will be put out this month. A college exposure tournament took place; almost 35, 18 and under girls teams participated. Several colleges came to see the players. Local restaurants saw about a 22% increase in sales over that weekend.

#### 2. Fall Ball

There were not quite enough teams this first year to have it solely here so it was combined with Chapel Hill; lots of compliments were received about the complex.

#### 3. Golf

a. First Tee

\$6000 was made last year. The Commission will need to decide if the tournament proceeds will still need to go to First Tee or if those funds should be used elsewhere. Mr. Farr & Mr. Focht would like to recruit more help to make the tournament bigger and better than ever.

4. Resignation of Chairman and election of new Chairman

Chairman Branam resigned from the Commission; he will still at the meetings as an advisory position. Andrew Focht moved to elect Nate Lambert as chairman. Brad Farr seconded.
